Under pressure to review more contracts with tighter budgets and shorter timelines, legal teams have long relied on Junior Lawyers or LPOs. But now, generative AI is stepping in and we asked: Can LLMs actually outperform human lawyers at contract review?

Methodology

To put our research to the test, we used ten real-world procurement contracts — anonymized and split between U.S. and New Zealand jurisdictions. Senior lawyers served as our gold standard benchmark.

Research Questions

Do LLMs outperform Junior Lawyers and LPOs in spotting legal issues?



Can LLMs review contracts faster than Junior Lawyers and LPOs?



Can LLMs review contracts more cheaply than Junior Lawyers and LPOs?



Results



Accuracy

AI is just as good — or even better — than people at spotting legal issues.

AI vs Humans: Determining Legal Issues

*Precision: how often the model correctly flags real legal issues.

AI vs Humans: Locating Legal Issues

*F-score: how well a model balances precision and recall.



Speed

AI reviews contracts up to 77 times faster than humans.

AI vs Humans: Time per Document

Cost

AI review is 99.97% cheaper than traditional methods.
